## **Privacy Policy**

QFund ("we," "our," or "us") takes your privacy seriously. Please read the following to learn more about our privacy policy. ### **What Information We Collect:**

We collect personally identifiable financial information, including but not limited to non-public personal information, as well as other types of personally identifiable information from you and from other sources as described herein (collectively, "Your Information"). We will not use or associate personally identifiable information (PII) with remarketing lists, cookies, data feeds or other anonymous identifiers. We also use Google Analytics and Site Master to analyze your use of our Website and the use of others. Analytical data is kept anonymous

## **How We Share Information:**

We may share Your Information with trusted third parties in order to:

- 4. Conduct statistical analysis; and
- 5. Provide our advertisers with editorial or feedback information.

We may share your information when the law demands it.
